With summer coming up we are looking forward to sending several CCS/CST child consumers to various summer camps and engaging them in healthy and appropriate activities utilizing CST funds. We are looking to utilize Camp U-Nah-Li-Ya and Camp Lake Lundgren. We also will be expanding to

having some child consumers go to camps at the UWGB campus as they offer various camps that we can match with consumer's interests and expose them to what it would be like to be on a college campus. All of these experiences allow for our child consumers to be exposed to new activities, new skills, healthy and appropriate child activities, and that there are many possibilities that they can pursue as they get older and that there is hope for them and more to the world than just their local community.

**7. Oconto County Report/Update**

2 referrals currently in process.

Recruiting for open positions including a CST/CCS Service Facilitator and CLTS worker.

Overviewed implementation of Peer Support Specialists and Parenting Peer Specialists utilizing Rehab Techs and the expansion of education and job training opportunities for consumers through New Beginnings. Also still looking to possibly bring on a Recovery Coach but this has not occurred yet and still in the discussion phase.

Robin Elsner updated that the SHARE Academy opened on Monday with one placement and will have two more placements next week. Robin also noted the "grant funded" joint venture with Marinette School District for School-based behavioral Health Services.
