1. Chairperson Sauve called the meeting to order at 9:00 a.m.
2. APPROVAL OF AGENDA  
**MOTION** (Nichols/Guarisco) to approve the agenda and the addendum as presented. Motion carried, no negative vote.
3. APPROVAL OF MINUTES  
**MOTION** (Baumgarten/Pillath) to approve minutes of July 8<sup>th</sup> meeting. Motion carried, no negative vote.
4. REPORTS BY COOPERATING AGENCIES – NRCS: REVIEW OPERATIONAL AGREEMENT  
No action was taken
5. TOWN OF PESHTIGO REZONE AMENDMENT  
**MOTION** (Pillath/Sauve) to send the rezoning request submitted by the Town of Peshtigo for parcel #024-00826.001 back to the Town of Peshtigo to allow the Town the opportunity to reconsider the action. Motion carried, no negative vote.
6. GYPSY MOTH SUPPRESSION PROGRAM  
**MOTION** (Nichols/Stibbe) to postpone any action on disbursement of reimbursement funds until the Wisconsin Department of Natural Resources provides the County with information concerning the County's options. Motion carried, no negative vote.
7. AMENDMENTS TO CHAPTER 9 OF MARINETTE COUNTY CODE OF ORDINANCES  
**MOTION** (Guarisco/Nichols) to have the Land Information Director incorporate wording into the proposed amendments that would allow the County to delegate to the towns interested in maintaining control over rural addressing the opportunity and authority to administer the program within their districts. Motion carried, no negative vote.
8. RESOLUTION SUPPORTING A CHANGE IN THE REGISTER OF DEEDS RECORDING FEE  
**MOTION** (Guarisco/Policello) to recommend to County Board the Resolution Supporting a Change in the Register of Deeds Recording Fee from a Per Page to a Flat Fee. Motion carried, no negative vote.



9. REGISTER OF DEEDS USER FEES  
**MOTION** (Baumgarten/Guarisco) to recommend to the County Board in September the 2009 Register of Deeds User Fees. Motion carried, no negative vote.
10. TOWN OF WAUSAUKE AND COMPREHENSVE PLANNING  
**MOTION** (Guarisco/Baumgarten) to authorize the Land Information Director, upon receiving notification from the Town of Wausaukee of their interest to participate in the Multi-jurisdictional Comprehensive Planning effort, to draft and enter into an agreement with the Town of Wausaukee for completion of the Towns Comprehensive Plan by the County and Bay Lake Regional Planning Commission for a fee of \$12,000 contingent upon Corporation Counsel approval of the agreement. Motion carried, no negative vote.
11. CHAPTER 15 OF THE MARINETTE COUNTY CODE OF ORDINANCES  
**MOTION** (Guarisco/Stibbe) to have the public hearing for Chapter 15 of the Marinette County Code of Ordinances on October 6, 2008 as part of the regular Land Information Committee Meeting, which will start at 9:00 a.m. Motion carried, no negative vote.
12. MARINETTE COUNTY TREE PLANTER PROGRAM  
**MOTION** (Nichols/Stibbe) to approve the purchase of tree planter bars not to exceed \$500.00. Motion carried, no negative vote. Supervisor Guarisco opposed.
13. WISCONSIN REAL PROPERTY LISTERS ASSOCIATION CONFERENCE  
**MOTION** (Pillath/Baumgarten) to authorize the Property Lister to attend the Wisconsin Real Property Listers Association Conference in Marquette County on September 17 – 19, 2008. Motion carried, no negative vote.
14. LAKE MICHIGAN LAND & WATER CONSERVATION LEGISLATIVE DAY  
**MOTION** (Sauve/Pillath) to authorize LIC Committee and/or staff attendance at the Lake Michigan Land & Water Conservation Legislative Day on September 15, 2008 in Brown County at the Land Conservation Office in Green Bay with per-diem and expenses. Motion carried, no negative vote.
15. VOUCHERS  
**MOTION** (Pillath/Policello) to approve vouchers as presented (\$24,250.31). Motion carried, no negative vote.
