3. PUBLIC HEARING ON SHORELAND/WETLAND ZONING AMENDMENTS

Those in attendance asked questions pertaining to the proposed amendments.

A few comments were received:

Mr. Twombly didn't see the reason for reducing the width of a stairway or walkway from 6 feet to 5 feet. Lefebvre stated that 5 feet is the width identified in NR115 and the County is required to make the amendment.

Mrs. Prudhomme, believed that the ADA provisions in the ordinance should be allowed to be used for visitors not just occupants and that any special provisions granted to accommodate ADA persons should be allowed to remain and not be removed.

Dennis McCullah stated that he appreciated the work that was put into the draft amendments and the fact that some common sense was used drafting these amendments over what was proposed a few years ago.
