- Judges have not been allowing Huber release for testing.
- Five incarcerated 16 to 18 year old students are working with Marinette schools for classes.

- Cynthia Russell Smith, Director of Student Services at Marinette High School has done a great job establishing the high school inmate educational program.

Kent Hoffmann informed the Committee that changes in the mental commitment process should have a positive impact on the County Budget.

Linda Dumke Marquardt discussed the Nichols trial costs.
